I would like to thank everyone for their participation in our virtual BTSN. We appreciate the positive feedback we have heard from families. On Friday, information regarding our transition to the Hybrid Model was emailed home. Please read this completely. It also includes information for our freshman and new student open house we will be having on October 8th and 9th. Information regarding the PSAT testing and Keystone exams has also been emailed home. I would like to remind you to sign up for the PSAT's using the google form link if you are a sophomore or junior. The deadline is October 1st. Any student who had Algebra 1, 10th grade literature or Biology last school year can take the Keystone exam for those courses in January. Information regarding Act 158 graduation requirements has been emailed home and is on our website. Links to sign up for the testing are included in the letter that was emailed home and are in this email. The first 2 pathways for graduation requirement are Keystone related for the class of 2022. Please read the information on our website relating to Act 158. To clarify Act 158: All students from the class of 2022 and younger will have options other than proficiency on the Keystone exams to fulfill graduation requirements. Students who take the Keystone exams and achieve proficiency on these exams fulfill their graduation requirements and do not need to look at other pathways. Students who do not achieve or do not take the exams will need to fulfill their graduation requirements through another pathway. There are 5 pathways. The Keystone exams were not mandated for the 2019-2020 school year due to Covid. MNSD did not want to eliminate giving our students the opportunity to take the Keystone exams to fulfill graduation requirements for the class of 2022. Those exams will be administered in January. There will be a 2 week test prep in December to assist our students with these tests. Every student who had either Algebra 1, 10th grade literature or Biology needs to complete the survey below whether they choose to take the test or not.
